

## **2023 GOEMANS Appliance Nightmare Contest Official Rules**

- 1. Eligibility:** Promotion is open to all legal residents of Ontario who are 18 years of age or older as of October 27, 2023. Employees, officers and directors of Goemans Appliances (the 'Sponsor'), their parents, affiliates, subsidiaries, agents, advertising and promotion agencies, their immediate family members (parents, children, siblings, spouses) and persons living in the same household (whether related or not), are not eligible to participate in the Promotion. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Promotion will open from 9:30amEST on October 27 until 11:59pmEST on December 10, 2023 ("Contest Period"). Void where prohibited.
- 2. How to Participate:** No purchase necessary. To enter, complete in full and submit the contest entry form at <https://info.goemans.com/applianceny nightmare> during the promotion period. There is one entry allowed per household.
- 3. Prize Details & Odds:** There is one(1) grand prize available to be won, consisting of one(1) new appliance to replace the appliance identified by the selected entrant as their 'nightmare' appliance. The maximum value of the replacement appliance shall not exceed \$5,000(MSRP). Prize also includes local delivery of the new appliance, valued at \$99.99. Any out-of-town incremental delivery charges will be the responsibility of the winner. Under these conditions, the winner may choose any one(1) appliance Goemans sells so long as it is the same category as their 'nightmare' appliance (ie. Fridge for fridge) and can be delivered prior to March 30, 2024. Specific model availability will be subject to availability at the manufacturer level and as such beyond the control of Goemans Appliances. The odds of winning depend on the number of eligible entries received. Prize must be accepted as awarded, with no substitutions and it is not redeemable for cash or transferable. If the MSRP value of the prize appliance is less than \$5,000, the difference shall be forfeited. All prize elements are subject to availability and substitution.

The selected entrant will be contacted by email the week of December 18, 2023 and be required to complete a prize Declaration and Release form before being named the official winner. If the potential winner fails to return the Declaration and Release form within 5 business days, the prize will be forfeited. The sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the sponsors to receive a selected entrant's response. Prize fulfillment will be subsequently arranged with all confirmed winners.
